**GOLF CART REGISTRATION PACKET**

Dear Resident:

This package provide the information you will need to register your golf cart for use on authorized side walks, cart paths and streets. The registration package consists of a registration and inspection form and information on the rules and regulations governing golf cart use in Palm Beach Polo and Country Club communities. In order to register your golf cart you will need to complete the following steps:

1. Complete the golf cart registration and sign where indicated.
2. Note that proof of insurance is required and you will need to contact your insurance agent to obtain coverage.
3. Have an access control officer inspect your golf cart (at the construction gate) and complete the form. Call 561-767-6409 to make an appointment for an inspection from Monday to Friday between the hours of 8 AM to 2 PM.
4. The POA requires that you read and understand the Golf Cart Rules and Regulations that are attached. The information is also available at the POA main office in the Tennis House or may be viewed on line at the POA's web site at [www.palmbeachpolopoa.org](http://www.palmbeachpolopoa.org)
5. A one time \$20.00 registration fee is required. Once paid, you will be issued two decals that will be placed on the front and back of the cart to indicate your cart has been approved for use in Palm Beach Polo.

**HAPPY AND SAFE CARTING!**

Please remember that using golf carts in Palm Beach Polo is a privilege, not a right. The POA reserves the right to revoke any and all golf cart registrations as deemed necessary. The POA Board of Directors also reserves the right to cancel this program at any time.

**GOLF CART RULES AND REGULATIONS**

We ask for your assistance in making this program a success. Please obey all traffic laws. Please do not allow unauthorized individuals to operate your golf cart. Please respect other residents by traveling in your golf cart in a safe and diligent manner. Driving on side streets, cart paths and sidewalks is permitted; however, pedestrians have the right of way. REMEMBER-golf carts must yield to pedestrians.

**Registration and Inspection:** A golf cart is defined under Florida Law as "A motor vehicle designed and manufactured for operation on a golf course for sporting or recreational purposes" To use a golf cart within the Palm Beach Polo cart paths, sidewalks and side streets, the golf cart must be registered with the POA and have some specific equipment. There will be a one time

\$20.00 registration fee and you will be required to have you golf cart inspected by the access control security group. Only properly equipped golf carts will be registered and permitted to be driven on side streets, cart paths and sidewalks.

**Equipment Requirements:** A golf cart must be equipped with efficient brakes, brake lights, emergency brake, reliable steering, safe tires, two headlights, two tail lights, a horn, a windshield and two numbered reflective decals issued by the POA.

**Basic Rules for Operation:** Golf carts and operators are required to obey the following rules. Failure to comply with POA rules may result in the issuance of a compliance citation and/or revocation of the golf cart registration and decal privileges for the entire residents.

- Golf cart operators must have a valid driver's license
- Golf carts must have a valid POA registration decals displayed in the front and rear of the cart in plain view.
- Golf carts must be covered with liability and property damage insurance as minimum coverage.
- Golf carts may be used on cart paths, side streets and side walks except where prohibited.
- Golf carts must be operated in a safe manner.
- The driver and passengers must be properly seated at all times when the golf cart is in motion. Do not exceed the number of passengers for which the golf cart is designed. Please understand and follow the manufacturer's operating instructions.
- Golf cart operators are required to follow all standard motor vehicle laws and Village of Wellington ordinances.
- When not in use golf carts must be properly parked in garages and designated covered parking areas.
- A golf cart may be operated at any time between sunrise and 10 PM on those areas that are permitted and authorized.
